

# Second wave raises concerns over NBFCs' retail loans: Icr

THE RESTRICTIONS ON movement imposed by various states due to surging COVID-19 cases are likely to affect collections of non-banking finance companies (NBFCs) and housing finance companies and may pose risks to the asset quality of their retail loans, according to a report. "The rising COVID-19 cases in April has again raised concerns on the asset quality of retail loans of NBFCs and HFCs given the increasing instances of lockdowns in various cities, coupled with a gradual rise in severity of such restrictions by some state governments," Icr Ratings said in a report. The restrictions on



stress if the inter-state restrictions are re-imposed, though even the current restrictions put in place in key geographies like Maharashtra and Delhi, where non-essential services are closed, would lead to the lower fleet utilisation for operators. Housing loans are expected to remain most resilient as was seen even last year given the secured nature of the asset class and the priority given by borrowers to repay such loans, it said. Datria said post the nationwide lockdown last year, a severe drop in collections was witnessed for most asset classes, though the availability of a moratorium provided a breather from an NPA-recognition perspective.

# Warbug Pincus buys HDFC's 24.48% stake in Good Host Spaces

GLOBAL PRIVATE EQUITY major Warbug Pincus on Thursday said it has become a "significant shareholder" in student accommodation provider Good Host Spaces by undisclosed sum. Baskin Lake Investment, an affiliate of Warbug Pincus, has picked up mortgage major HDFC's 24.48% stake in the company, and has also topped it with a primary investment, an official statement said. Existing shareholder Goldman Sachs and Baskin Lake will support the future growth of Good Host by investing additional capital to fund the company's growth objectives, the statement said. Good Host is the first on-campus student housing platform, and has become largest owner and operator of student accommodation assets, operating about 18,000 beds at Manipal University, O P Jindal Global University and Shoolini University, it said.

# घरोघरी लसीकरण करण्याबाबत पुनर्विचार करा!

## उच्च न्यायालयाची केंद्र सरकारला सूचना

**मुंबई :** ज्येष्ठ नागरिक आणि शारीरिक व्यंग असलेल्यांना वाऱ्यावर सोडले जाऊ शकत नाही. उलट त्यांची अडचण समजून घेणे गरजेचे आहे, असे नमूद करत घरोघरी जाऊन लसीकरण करणे अशक्य असल्याच्या आपल्या भूमिकेवर फेरविचार करण्याची सूचना मुंबई उच्च न्यायालयाने गुरुवारी केंद्र सरकारला केली.



### इस्त्रायल-लॉस एंजेलिसचा दाखला...

भारतीय संस्कृतीत लहान मुले आणि ज्येष्ठ नागरिकांना प्राधान्य दिले गेले आहे. लहान मुले व ज्येष्ठ नागरिक त्यांची काळजी घेण्यासाठी असमर्थ असल्यामुळे आपल्याला त्यांची काळजी घ्यावी लागेल. करोनासाख्या महासाथीपासून वाचण्याचा लसीकरण हा सध्या एकमेव मार्ग आहे, असे सांगताना न्यायालयाने या वेळी इस्त्रायल व लॉस एंजेलिसचे उदाहरण दिले. इस्त्रायलमध्ये निगम्याहून अधिक जनतेचे लसीकरण झाले असून लॉस एंजेलिसमध्ये कारमध्ये बसूनही लसीकरण केले जात आहे. आपणही असे मार्ग अवलंबण्याची आवश्यकता असल्याचे न्यायालयाने म्हटले.

### केंद्राचा दावा...

बऱ्याचशा ज्येष्ठ नागरिकांना गंभीर आजार असतात. त्यामुळे लसीकरणानंतर त्यांना ३० मिनिटे वैद्यकीय देखरेखीखाली ठेवावे लागेल. घरोघरी जाऊन लसीकरण केल्यास हे शक्य होणार नाही, असा दावा केंद्र सरकारतर्फे अतिरिक्त सॉलिसिटर जनरल अमिल सिंघ यांनी केला.

### उपलब्धतेविषयी प्रसारमाध्यमांतून माहिती द्या...

सध्या घडीस केवळ तीन ते चार दिवसच पुरेले एवढा लशीचा साठा उपलब्ध आहे, मात्र लवकरच हा साठा उपलब्ध होईल, असे राज्य सरकारतर्फे महाधिवक्ता आशुतोष कुंभकोणी यांनी न्यायालयाला सांगितले. त्यावर न्यायालयाने चिंता व्यक्त केली. तसेच नागरिकांचा त्रास थांबवण्यासाठी कोणत्या लसीकरण केंद्रावर लस उपलब्ध आहे, ती कधी प्रमाणात उपलब्ध आहे, याची माहिती प्रसारमाध्यमांतून प्रसिद्ध करण्याचे आदेश न्यायालयाने या वेळी सरकार आणि पालिकेला दिले.

## अठरा वर्षावरील विद्यार्थ्यांना विद्यापीठ आणि महाविद्यालयांत लस

**मुंबई :** राज्यातील १८ ते २५ वयोगटातील विद्यार्थ्यांचे करोना लसीकरण महाविद्यालय किंवा विद्यापीठाच्या माध्यमातून करण्यासाठी प्रयत्न करण्यात येत आहेत, अशी माहिती उच्च व तंत्र शिक्षण मंत्री उदय सामंत यांनी गुरुवारी दिली.

### दहावीच्या मूल्यमापन योजनेची प्रतीक्षा...

दहावीनंतर तंत्रशिक्षण पदविका अभ्यासक्रमाला (पॉलिटेक्निक) प्रवेश घेणाऱ्या विद्यार्थ्यांची संख्याही मोठी आहे. दहावीची परीक्षा रद्द झाल्यामुळे या अभ्यासक्रमाच्या प्रवेशाबाबतही पेंच निर्माण झाला आहे. 'दहावीच्या विद्यार्थ्यांचे मूल्यमापन कसे करण्यात येणार आहे त्याची योजना जाहीर झाल्यानंतर पदविका अभ्यासक्रमाच्या प्रवेशाबाबत निर्णय घेण्यात येईल,' असे सामंत यांनी सांगितले.

### ४८ खासगी केंद्रे बंद, तरीही लसीकरण वेगात

मुंबई : लससाठ्याअभावी गुरुवारी देखील ४८ खासगी लसीकरण केंद्रे बंद ठेवण्याची वेळ आली; मात्र पालिकेच्या ४२ केंद्रांवर लसीकरण सुरू होते. दिवसभरात तब्बल ४८ हजार लोकांना लस देण्यात आले. मुंबईतील लसीकरण केंद्रांची संख्या टप्प्याटप्प्याने वाढवली जात आहे. सध्या मुंबईत १३२ केंद्रांवर लसीकरण होते आहे. त्यापैकी ४२ पालिकेची केंद्रे आहेत, तर ७३ खासगी रुग्णालयात आहेत. गुरुवारी एकूण ४८ हजार १५२ लोकांना लस देण्यात आली. त्यापैकी २१ हजार ९९० लोकांनी लशीची दुसरी मात्रा घेतली तर, २६ हजार १६२ लोकांनी पहिली मात्रा घेतली. खासगी केंद्रांवर दिवसभरात केवळ २ हजार ८०० लोकांनाच लस देता आली. मात्र पालिकेच्या केंद्रांवर तब्बल ३८ हजार लोकांना लस देण्यात आली. सध्या एकूण २१ लाख लोकांना लस देण्यात आली आहे.

राज्यातील अकृषी विद्यापीठांच्या कुलगुरूंची बैठक सामंत यांनी घेतली. त्यावेळी लसीकरण मोहिमेबरोबरच विद्यापीठांच्या परीक्षा, पुढील शैक्षणिक वर्षाचे नियोजन यांबाबत चर्चा करण्यात आली. शैक्षणिक वर्ष वेळेत सुरू करण्यात येणार असून याबाबत राज्यात, मुख्यमंत्री, आरोग्यमंत्री यांच्याशी चर्चा करून अंतिम योजना जाहीर करण्यात येईल असे सामंत यांनी सांगितले. उच्च शिक्षण विभागाचे संचालक धनराज माने, तंत्रशिक्षण संचालक अभय वाघ, सीईटी सेल आयुक्त चिंतामणी जोशी, कला संचालक राजीव मिश्रा हेदेखील या वेळी उपस्थित होते.

## दोन आठवड्यांत २६ पोलिसांचा मृत्यू

**मुंबई :** गेल्या दोन आठवड्यांत करोना संसर्ग झालेल्या २६ अधिकारी, अंमलदारांचा मृत्यू झाल्याची माहिती राज्य पोलीस मुख्यालयातून देण्यात आली. गेल्या वर्षी मार्चपासून आतापर्यंत एकूण ३९० पोलीस करोनाने मृत्युमुखी पडले. संसर्ग पसरू नये यासाठी प्राधान्याने

पोलीस दलात लसीकरण सुरू करण्यात आले. मात्र लसीकरणाचा पहिला टप्पा अद्याप झालेला नाही. त्यातच दुसरी लाट थोपवण्यासाठी लाटण्यात आलेल्या कठोर निर्बंधांच्या अंमलबजावणीची जबाबदारी पोलिसांवर आली. ही जबाबदारी पेलताना पोलीस दलातील संसर्ग प्रसार आणखी वाढण्याची शक्यता आहे.

वर्षभरात राज्य पोलीस दलातील ३४ हजार ५८७ अधिकारी अंमलदार बाधित झाले. सध्या ३ हजार ७०० जण उपचार घेत आहेत. तर मुंबई पोलीस दलातील ८ हजार ३७२ अधिकारी, अंमलदार बाधित झाले आहेत. त्यापैकी ७ हजार ५९८ जणांनी करोनावर मात केली. यातील बहुसंख्य अधिकारी कामावर रूजू झाले आहेत.

**मुद्दा काय?** धूम्रपानामुळे फुफ्फुसांवर परिणाम होतो आणि करोनाही फुफ्फुसांशी संबंधित आजार आहे. त्यामुळे गेल्या वर्षी करोनाबाधित झालेल्या, करोनाने मृत्युमुखी पडलेल्यांपैकी किती जण धूम्रपान करणारे होते याचा काही अभ्यास झाला आहे का?, असा अभ्यास झाला असेल आणि त्यातून दुष्परिणाम झाल्याचे पुढे आले असल्यास काही काळाकरिता धूम्रपानावर बंदी घालायला हवी, असे न्यायालयाने म्हटले आहे.

याबाबत माहिती घेऊन सादर करण्यास न्यायालयाने सांगितले. धूम्रपान करणे हा मूलभूत हक्क असून आपण कुठेही, कधीही धूम्रपान करू शकतो, असे नागरिकांकडून म्हटले जाऊ शकते. परंतु सार्वजनिक हिताच्या दृष्टीनेही करोनास्थितीचा विचार करावला हवा. सरकारनेही त्याकडे लक्ष द्यायला हवे. तसेच अशा प्रकारच्या अभ्यासातून दुष्परिणाम समोर आल्यास तात्पुरत्या काळाकरिता धूम्रपानावर बंदीचा घालण्याचा विचार करावला हवा, असे न्यायालयाने म्हटले.
