## INTIMATION REGARDING PRE-REQUISITES FOR PAYMENT OF FINAL DIVIDEND FOR FY2023-24 – REQUIRING ACTION AT YOUR END

Dear Shareholder,

The Board of Directors of the Company has recommended a dividend of Rs. 30 per equity share (300%) for the FY 2023-24, subject to approval by the Members at the ensuing Annual General Meeting ('AGM') scheduled to be held on Thursday, August 29, 2024.

Accordingly, the dividend, if declared in respect of the equity shares held by you in the Company shall be processed on or before September 27, 2024. However, since your folio is not KYC compliant, hence as per **SEBI Master Circular No. SEBI/HO/MIRSD/POD-1/P/CIR/2024/37** dated May 07, 2024 the Company is mandated to withhold the same.

## SEBI as per the above referred Circular has directed as under:

- i. It shall be mandatory for all holders of physical securities in listed companies to furnish PAN, Choice of Nomination, Contact details (Postal Address with PIN, Mobile Number), Bank account details and Specimen Signature for physical folios.
- ii. Any payment including dividend, interest or redemption payment in respect of such folios is permitted only through electronic mode w.e.f. April 1, 2024, and such payment shall be made electronically only upon furnishing of PAN, KYC details by holders of physical securities.

We therefore request you to update your PAN, contact details (Postal Address with PIN, Mobile Number) Bank account details and Specimen Signature by submitting the relevant documents viz: Forms ISR-1, ISR-2, SH-13 or ISR-3 so as to enable the Company, to remit the withheld dividend in <u>electronic mode only</u>, at the earliest possible.
